Follow-Up to February Meeting

Jean Wenger, our AALL Board Visitor at the February meeting, was asked several questions by members during her talk. Some of them she was not sure about, and said she'd get back to us. She did! – here are her answers:

Dear HALL Members:

Thank you for your questions and interest in AALL. Please find below responses to questions posed during my visit. Please contact me if you have additional questions.

1) Making Programs available on ALLNET - programs given grants by the Continuing Professional Education Committee (CPE):

Grant recipients are required to devise a method of sharing the program. The committee prefers to fund well-developed programs that make a good faith effort to share in some way. AALL entities can be creative in how they plan to share. Podcasting or taping is one option. Most of our recipients have been able to meet the obligation in some way. The CPE committee can assist in this area.

The committee has found that the way the sharing is marketed to a speaker makes a huge difference. Expressing to a speaker that the audio/video will be limited to 60 minutes maximum, available to AALL membership only and can be posted for a limited time usually is enough to get the commitment.

Every speaker is required to sign a speaking agreement whether or not the program is being taped. The form asserts their commitment to the program and protects AALL. The speaker form can be modified upon speaker request, if there are disagreeable terms. The program coordinator can contact Celeste Smith, AALL Education Manager (csmith@aall.org) with the speaker's request for modification.

2) Promotion of Continuing Professional Education Programs:

Julia O'Donnell, Director of Publications (jodonnell@aall.org), and Celeste Smith are looking into ways the programs can be promoted including FTDOs (E-Newsletters: From the Desk of AALL President). The CPE committee can also provide periodic announcements.

Programs such as Teaching the Teachers Conference, that received grant funds, are a direct outgrowth of the grant program. AALL/CPE in turn was able to make it available to the wider membership.

3) AALL Use of RSS feeds:

AALL does not have RSS feeds at this time, but it is being investigated as members have requested this option.

4) AALLNET:

It is recognized that AALLNET needs a revamp. Improvements to AALLNET are being planned for the future. However, no specifics are available at the moment.

5) Archiving of Job Hotline Postings:

Jobs listings are posted for 180 days. The reason is because when jobs were up indefinitely, "listers" were expressing concern that their "old" jobs were still posted and that the salary ranges for new postings (for the same or similar positions) were different. AALL does maintain a record of all postings, but only that past 180 days are online. Members can contact Hannah Phelps, Membership Services Coordinator (hphelps@aall.org) if they have any questions about earlier postings.

Volunteer Guidelines and Safety Rules



Cooperation with the rules and guidelines that have been established will make your experience at the Houston Food Bank rewarding and safe. Failure to follow these rules could result in serious injury or termination from the Volunteer Services Program.

All volunteers must enter and exit through the front door. Volunteers do not have to sign out for the fifteen minute break, but are expected to return to work promptly.

Volunteers are allowed to tour the Houston Food Bank; however, a staff member must be present to facilitate the tour. Volunteers must stay in assigned work areas. Volunteers must be at least eight years old. Volunteers under the age of sixteen must be accompanied by an adult at all times.

Eating, drinking, smoking, radios, headphones, purses, bags, and other personal items are not permitted in the warehouse. Smoking is permitted outside and 25 feet away from the main building. Under no circumstances will any person be allowed to work in the warehouse while under the influence of alcohol or drugs.

Although the Houston Food Bank is a warehouse environment, you must dress appropriately and modestly at all times. Please observe the following guidelines:

- Wear close-toed shoes at all times.
- No extremely loose clothing or dangling jewelry
- No clothing with obscene or controversial messages
- No overly tight or sexually suggestive clothing
- No sandals or flip-flops are allowed in the warehouse
- Shorts are permitted, but must be midlength to the knees
- No muscle shirts on men or women.
- Please do not wear fanny packs or camera cases.

All dock and warehouse floors, aisles, and sitting areas on the dock are to be continuously free of debris, clutter and spills. Empty pallets must lay flat on the ground – not on the side or upright.

Only trained Houston Food Bank staff will be allowed to operate forklifts or other power equipment. All warehouse traffic signs, safety signs, and signals must be followed. All traffic lanes for pedestrians and forklifts must be observed. Be aware of forklift traffic and heed all horns.

Do not block emergency exits, fire extinguishers, or any equipment requiring immediate access. In case of a fire in the warehouse or fire drill, immediately stop what you are doing and proceed to the nearest fire exit.

No horseplay is permitted in the warehouse. Riding on pallet jacks and climbing on equipment, machinery, racks, pallet stacks is prohibited. Volunteers must report all accidents and injuries or unsafe conditions or practices to your supervisor.

Any pre-existing medical conditions that would restrict a person from performing any physical activities must be reported and on file before working in the warehouse. Use correct lifting techniques at all times. Do not attempt to lift over 50 pounds without assistance. Use proper protective gear provided for various jobs, such as goggles and gloves.

<u>Volunteers may use cell phones only in the front lobby</u>. <u>Due to safety and security, this is strictly enforced at all times</u>.

- Take the second exit after you cross over I-10 north of downtown. This exit is Collingsworth/Cavalcade.
- Stay on the feeder road to the second light, which is Cavalcade. Turn left on Cavalcade under US 59.
- The next signal light is Jensen. Turn right on Jensen.
- The first street on your right will be Vintage. Turn right on Vintage.
- The Houston Foodwill on your right. Travel to the end of the street and turn right on US 59 southbound feeder. Enter the gate to the Houston Food Bank parking lot. There is only one entrance to our front lobby.

From US 59 Southbound from Intercontinental Airport, Humble and Kingwood


- Exit Cavalcade, which is the first exit after 610
- Cavalcade exit will place you on the southbound feeder road in front of the Houston Food Bank. Move to the far right lane and enter the Houston Food Bank main entrance.

From I-45 Northbound from Downtown

- Exit Cavalcade and turn right
- Continue down Cavalcade for roughly 2 miles, until you get to Jensen. Turn left on Jensen
- The first street on your right will be Vintage. Turn right on Vintage.
- The Houston Foodwill on your right. Travel to the end of the street and turn right on US 59 southbound feeder. Enter the gate to the Houston Food Bank parking lot. There is only one entrance to our front lobby.

From I-45 Southbound from Intercontinental Airport and The Woodlands

- Take the 610 East exit
- Traveling east towards US 59, take the "59 South Downtown" exit
- You will see the Houston Food Bank building on your right from the overhead ramp as you enter US 59 South
- Take the Collingsworth exit
- Make a U-turn under US 59 at Collingsworth to the northbound feeder
- At the next light, turn left on Cavalcade under US 59. Turn left on Cavalcade under US 59
- The next signal light is Jensen. Turn right on Jensen.
- The first street on your right will be Vintage. Turn right on Vintage.
- The Houston Food Bank will on your right. Travel to the end of the street and turn right on US 59 southbound feeder. Enter the gate to the Houston Food Bank parking lot. There is only one entrance to our front lobby.

Dr. Patricia Montiel Overall, Assistant Professor, University of Arizona School of Information Resources and Library Science


Dr. Overall will discuss the Knowledge River program at the University of Arizona which focuses on the needs and perspectives of the Hispanic and Native American communities.
