Working in the Business Information Center: It's a Hoot!

I experienced a true homecoming this year. In July, I became employed once again by Rice University in the Jesse H. Jones Graduate School of Business. Five years ago, prior to my law firm positions, I worked at Jones School as a research analyst. I graduated from Rice so it has always been special to me.

I enjoy my new position as a business librarian every day. How can you not like working with smart people in an attractive academic setting? And, how many libraries have patrons who visit with their pet rabbit in tow? We actually have such a person who occasionally brings her pet in a carrier.

Thought I'd give you a quick look at life in the Business Information Center, otherwise known as the BIC. Our library is a branch of Fondren Library, the main library at Rice. Fondren is celebrating sixty years of service during November.

Our director, Peggy Shaw, has managed the business school library for over twenty years. My associate, Bill Coxsey, has been with the BIC for six years, and our weekend employee, Bobbie Foval, for ten years. We are also supported by a cast of undergraduate and graduate students who work shifts between classes, at night and on weekends. We're open until 9:30 p.m. during the week and until 6:00 p.m. on Friday and Saturday.

On a typical weekday, I maintain the reserve collection, check out books and handle returns, and assist the students with reference and research questions. I currently have a long term research project for one of the professors. This involves reviewing her previous papers, running literature searches, designing a survey for corporate management and analyzing the results. The final product will be a paper published in one of the accounting or management journals.

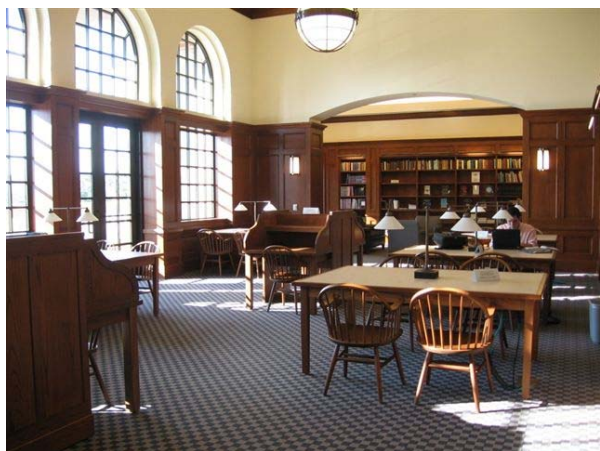
Jones Graduate School has three MBA programs--the full time MBA, Executive MBA, and MBA for Professionals. There are over 600 students enrolled in the 2009-2010 programs. Rice has recently added a business minor course of study for undergraduates.

Our online business resources are extensive. You can see a sample at Fondren's website, <http://library.rice.edu>. We also have additional subscriptions such as Investext and MarketLine which are available onsite for anyone with a Rice ID. Our business print collection has 23,822 volumes including journals and international annual reports.

Aside from the people at Rice, one of the most enjoyable things about my job is the place itself. McNair Hall has plenty of windows and you can see the Texas Medical Center from the south side of the building. The abundance of natural light makes it a comfortable and inviting place to work and study. The building is only seven years old, so it still looks fresh and new. A lovely patio with trees and benches is outside the windows by my desk.

We're located on the second floor of McNair Hall at Rice. I hope you'll pay us a visit soon.

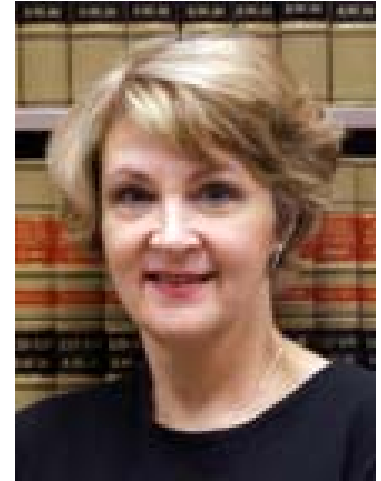

Sue is the Research Coordinator in Greenberg Traurig's Houston office. Greenberg has 1750 lawyers in 30 locations – the firm has librarians in 10 of these locations, covering all the U.S. time zones. Recap: HALL Fall Seminar

This year's Fall seminar was focused on "Surviving the Economic Times: Law Libraries and Librarians." We had a number of speakers that provided insightful information about the impact the economy has made on our profession and provided useful tips for surviving the current times. The seminar was divided into three segments: a general overview of how the economy has affected the profession in general, how the economy has affected law libraries, job searching in the current economy and dealing with the changes.

Blythe McCoy with Thomson West kicked off the seminar with a great presentation on "Impact of Economic Downturn on the Legal Industry". She walked us through various aspects of how the economy made a financial impact on the legal industry. Some of the impacts included a decline in firm revenues which in turn caused changes in firm structure, layoffs, salary freezes, stricter control over spending and legal process outsourcing. She also discussed long term implications which included associate salary reductions, alternative compensation and alternative fee arrangements. Overall, firms and libraries are having to do more with less and many firms are adopting new business practices on account of the changed economy. The good news? Most anticipate that the industry will recover by mid 2010.

The second part of the seminar moved to a different segment which addressed how the economy has affected libraries. In this segment we heard from Decarlous Spearman, Library Director, Texas Southern University, Greg Lambert, Library & Records Manager, King & Spalding L.L.P. and Toby Brown, Knowledge Management, Fulbright & Jaworski, L.L.P. DeCarlos presented on the changes that the TSU library faced on account of the economy. Some of the noted impacts included a strict review of the collection, the possibility of not renewing certain subscriptions, and the sharing of some of the library space with other departments.

Greg and Toby provided an insightful presentation of how the position of the law librarian has, and will continue to change. Clients are changing the way they outsource work and in turn, firms are changing business models and libraries are changing along side all of this. changes is the combining of the library under the umbrella of the IT department. Librarians are now needing to integrate themselves more into the client matters and the knowledge management functions than before. They also discussed ways in which law firms might try to recoup expenses for electronic databases using products such as Research Monitor to track usage and recoup this cost.

The seminar also featured a segment on searching for jobs in the current economy. We heard from Stacey Johnson, a student from the University of North Texas who gave a student's perspective of navigating the current job market. One of the main suggestions she gave was to join professional organization to make connections. You never know when that connection might turn into a job! Mon Yin Lung, Associate Director, University of Houston, O'Quinn Law Library, discussed what an academic law library looks for in potential candidates. She did a fantastic job of taking us through the process that candidates undergo in applying for a position within their library. She provided great suggestions for those seeking to apply for academic positions.

In the third segment of the seminar, Dr. Diana Dale, AEP Consultant, discussed ways of adapting to change and thriving in a changing environment. She discussed tips for coping with the stress often brought by the changes in the workplace.

At the end of the seminar, Ann Patterson and Saskia Mehlhorn briefly previewed the new HALL website. It looks fantastic! Thanks for all your work! Overall, the seminar was informative and timely. It is important to know how libraries are changing and the new things that may be expected of us and of our profession in general. I want to thank our speakers for their wonderful presentations and thank Thomson West and SWALL for their sponsorship.

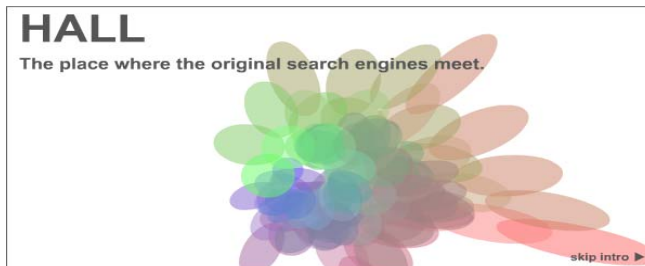
