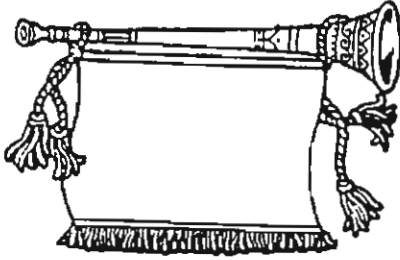

From The President

Kathy Larson, a member of the AALL Executive Board and a member of our Chapter, accepted the invitation from the Officers to be the official visitor from AALL at the Chapter meeting in Oxford next April. Kathy joined our chapter last year when she took a position with a law firm in Fairfax, Virginia, and she did not hesitate in becoming busy in Chapter activities. Those of you who saw the Longbranch Library skit in Reno may have recognized Kathy as one of the barroom girls. To demonstrate our support for one of our newer members in a top AALL leadership post, the Chapter Officers agreed to invite Kathy as our official visitor for our meeting next April.

I have been impressed by the way that our Chapter Committees this year have organized and undertaken some of the important business facing them. Hazel Johnson and the Publicity and Public Relations Committee have developed a plan of regular contact with the library schools in our region. Lisa Williams and the Publications Committee have the new membership directory well

underway. Pam Williams and the Articles and Bylaws Committee are drafting amendments for our consideration at the Annual Meeting, dealing with staggering the terms for our Secretary and Treasurer, among others. Sue Roach and the Membership Committee have under consideration a proposal to create a student membership category in response to suggestions from students in the library school at Atlanta University. I could go on and on with all the good work underway in the Committees!

Soon, the Chair of each Committee will receive the first draft of our proposed Chapter Procedures Manual for review. Adopting a procedures manual will prevent a committee from having to re-invent the wheel each year in defining responsibilities and getting organized.

Prospects look good for a joint meeting with the Southwestern Association of Law Libraries in 1992. Carol Billings and her special committee are working with members of that chapter to determine dates and location. One librarian in a state bordering the two chapters expressed some interest in hosting the event. So, we may be able to proceed very soon with some firm plans.

In addition to reporting (and supporting) the work of our Chapter through these President's messages, I want to bring to your attention issues that we face as information professionals. One

such issue might arise in the aftermath of the Webster v. Reproductive Health Services decision.

I suspect that most chapter members, like I do, have strong feelings about abortion, and I do not want to debate the issue here. Instead, I want to raise a concern about what might occur as state legislatures turn to the Missouri statute as a model for regulating abortion. Specifically, could those of us who work in state-supported law libraries violate the law if we provide reference assistance to a woman seeking information on abortion.

Sections of the Missouri statute prohibit public employees, defined as "any person employed by this state or any agency or political subdivision thereof", acting within the scope of their employment, from performing or "assist[ing] an abortion, not necessary to save the life of the mother". Mo. Ann. Stat. §§ 188.205, 188.210.

While a court would probably decide that this language applies only to health care professionals, the remainder of the section draws the circle much larger. "it shall be unlawful for a doctor, nurse or other health care personnel, a social worker, a counselor, or persons of similar occupation who is a public employee within the scope of his employment to encourage or counsel a woman to have an abortion not necessary to save her life." § 188.210.

Again I doubt that a court would apply this to a reference librarian who looks up the address and telephone number of a clinic. But, I fear that other state legislatures might react with statutes containing even broader language, leaving us to guess whether an act applies to librarians. Please be aware of

what your state legislature considers in its next session, and get involved if you are concerned about the potential effects of this kind of legislation.

**Oxford, Mississippi
April 7-8, 1990**

SEAALL is sponsoring a management institute focusing on library organizational development immediately following the 1990 Annual Meeting. The institute will take place on the afternoon of April 7th and the morning of April 8th. The registration fee will be \$35.00.

The institute, entitled "Organizational Development: Library Power and Performance", will be presented by Kaycee Hale, Executive Director of the Resource and Research Center of the Fashion Institute of Design & Merchandising. Ms. Hale, an extremely popular speaker on library management issues, annually speaks to dozens of library organizations throughout the country.

The Saturday afternoon session

entitled "leadership Options and Opportunities: Maximizing Internal Development" will focus on team building, communication, and staff development, motivation and morale within the library.

The Sunday morning session entitled "Dynamic Organizational Skills: Maximizing External Effectiveness" will focus on the library in its larger institutional setting (for example, the university or the law firm). Marketing the library and the library's role and image in the larger organization are among the topics that will be addressed.

The award will be announced at the Annual Meeting in Oxford. Please give this some serious thought. We believe the first award confirmed that this is a very effective way for us to publicly recognize someone who has devoted considerable time and energy to the work of the Chapter and the benefit of us all.

Applications for the Lucile Elliott Scholarships are now available. At least four scholarships of \$300.00 each will be awarded for the 1989/90 fiscal year. The award is to be used for any purpose reasonably designed to improve one's career in law librarianship. Preference will be given for attending any activity sponsored by the Southeastern Chapter or an AALL Institute. Any member of SEAALL who has not received the Lucile Elliott Scholarship within the past three years is eligible to win.

All who may have a need are urged to apply! Newer members (3 years or less) are especially encouraged to participate. When the applicant pool permits, scholarships will be awarded on a 70:30 newer members to older members ratio.


