Several vendor representatives also will be on hand to exhibit their legal information products. Please support this effort to provide personal contact with vendor representatives at the regional level. This activity is beneficial to SEAALL, its member libraries and publishers. Following is information about SEAALL's support for the National Conference on Legal Information Issues to be held in conjunction with the AALL Annual Meeting in Pittsburgh. The National Conference presents a great opportunity to network with colleagues in the legal community and to showcase the excellent educational opportunities provided by our Association. At the same time, attention will be focused on the problems and opportunities presented by the information revolution.

AALL President Carol Billings sent a packet of information to all chapter presidents to solicit sponsorship for delegates to the National Conference. A special brochure about the programs for the National Conference was also mailed with the December newsletter to all AALL members. SEAALL's Executive Board is considering ways to support one or more delegates. Let me assure you that we all agree that any financial support provided should not negatively impact SEAALL's ability to support our own activities. The cost for sponsoring a delegate is a minimum of \$150 (to cover meal events normally covered by the AALL registration

fee). Transportation and hotel expenses also may be covered if they are not provided by the delegate's employer and do not exceed available SEAALL funding.

The Board will select delegates and determine support for expenses from the pool of potential delegates recommended by SEAALL members. Currently we have one proposed delegate and hope to sponsor two more. A request for delegates was posted on law-lib and private law lib-l. Please contact me if you do not have access to these list serves and would still like to recommend a delegate.

We also are looking forward to the 1997 SEAALL Annual Meeting. Over the years the Southeastern Chapter has met at a variety of locations that have each provided an engaging local setting and memorable events. It is very helpful (and a lot more fun) to identify a Local Arrangements Chair/Committee well in advance of the Annual Meeting. Please let me know if you would like to volunteer your site!

Congratulations to recipients of Lucile Elliot Scholarships, and thanks to the Scholarship Committee for their hard work! This year SEAALL awarded 6 Scholarships to chapter members.

Public Relations

Government Relations

The December, 1994 issue of *Information Today* included an article about a new statewide electronic library of information in Texas. In addition to other materials, the Texas State Electronic Library includes Texas legislation available through the

Texas Legislative Council's gopher.¹ After reviewing this article about Texas, the SEALL Government Relations Committee decided to investigate similar services that are available for the states in the Southeast. Sandra Dyer (UNC) and Kelly Browne (Tennessee) assisted with the following information. All states are not listed below, but the committee will report on the other states in the next issue.

ALABAMA: DIALUP is an acronym for the Alabama Office of the Secretary of State on-line subscriber service. DIALUP provides access to corporate records, Uniform Commercial Code filings in the Office of the Secretary of State, Fair Campaign Practices Act data, Notaries Public, and Acts of Alabama legislation via a modem attached to a personal computer. Subscribers must register for access to DIALUP through the Secretary of State's office (205-242-7200, ask for the DIALUP Coordinator). If you would like a copy of the brochure describing the DIALUP service, contact Timothy Coggins at the University of Alabama.

GEORGIA: Georgia has a new dial-up information system called "Georgia Net" that contains bills, notices of the General Assembly, and the unannotated state code. Specific software to access the system is required. There is a \$75.00 registration fee, plus a \$0.45 per minute connect charge. Legislation has just been introduced to allow schools and universities free access to the system. There is some indication that there might be free access to public libraries also. For more information about Georgia Net, call 404-651-8690. Martha Lappe (404-651-5822), the Georgia State Law Librarian, would be happy also to answer questions about this system.

KENTUCKY: Kentucky has established the Kentucky Information Systems Commission, which is charged with managing government information, including broad public access to

non-restricted public records and efficient dissemination of mission-related information. One guideline in the "Information Policy Statement" of the Special Committee on Information Policy of the Kentucky Information Systems Commission states that "state agencies should provide online access to non-restricted government information," but it leaves online access at this point to the discretion of the individual agencies. James A. Nelson is a member of the Commission and also is the State Librarian and Commissioner of Library and Archives.

LOUISIANA: Louisiana has a system in place that is similar to Alabama's DIALUP. It provides access to legislation, AG opinions, administrative regulations and materials. The price is \$50.00 per month, plus a charge per minute. Louisiana is developing the LANET system also, which will offer access to legislative information. This system is not functioning yet, but should be available later this year. Contact Mike Baer at 504-342-0629 for additional information.

MISSISSIPPI: Nothing is available on the Internet or dial-in according to the staff at the Legislative Reference Bureau of the Mississippi Legislature. (There is pending legislation, however, requiring laptop computers for each legislator; therefore, electronic access likely will follow from this legislation.)

NORTH CAROLINA: The North Carolina General Assembly Legislative Internet Access Program contains the text of North Carolina bills. There is no charge for access. You can access the system via ftp (ftp@legislature.state.nc.us; login: anonymous; password: your email address) or via gopher. To obtain an instruction manual, contact the North Carolina General Assembly Legislative Automated System Division at 919-733-6834, or e-mail to leginfo@ftp.legislature.state.nc.us.

SOUTH CAROLINA: Nothing is available on the Internet or dial-in according to the staff at the South Carolina Legislative Library.

VIRGINIA: The Legislative Information System was developed last year; it contains the text of all bills since the system's inception. There is a \$100 registration fee for an identification number and the software necessary to dial into the system. There also is a \$20 per hour connect charge. A special feature of this system is that a user can create personal lists to track specific bills. For more information and a copy of the user guide, contact the Help Desk at 804-786-9631.

Kelly Browne (Tennessee) forwarded an interesting case dealing with the Open Records Act in Georgia. The Georgia Supreme Court in *Jersawitz v. Hicks*, 448 S.E.2d 352 (Ga. 1994) held that a computerized database of real estate deed records currently available to the public on computer tape was a "public record" within the meaning of the Open Records Act, but the clerk of court is not required to create a new program to provide public access with personal computers. The requirements of the Open Records Act are satisfied by making records available to the public on computer tape; records do not have to be available via a telephone modem on a personal computer. The court concluded, "While we are mindful that the prevalence of computers in homes, offices, and schools may make on-line access to computerized records desirable, requiring that means of access must be addressed by the General Assembly." (448 S.E.2d at 353)
