# In Memoriam

Caroline Chandler Heriot, law librarian and professor of law at the Marshall-Wythe School of Law, College of William and Mary, died on Monday, December 28, 1981, at Georgetown University Hospital in Washington, D.C. Professor Heriot had been ill since May, 1980. From 1976 to 1978, she was president of the Southeastern Chapter of AALL.

Professor Heriot was a native of Dalzell, South Carolina. She graduated from Lander College in 1939 and received a B.S.L.S. from the University of North Carolina in 1954. She graduated from the University of North Carolina Law School in 1960.

Miss Heriot's professional law library career began at her alma mater in Chapel Hill in 1956, where she served as assistant law librarian. She assumed the position of assistant law librarian at the University of Iowa College of Law in 1960. One year later she became head law librarian and was instrumental in moving that library into a new facility. She served in that capacity until 1965, when she accepted the position of librarian at the New Mexico Supreme Court Library. She accepted an appointment in 1967 as librarian at Loyola University in New Orleans, Louisiana. While in New Orleans she rose from the rank of assistant professor to professor and was responsible for planning and moving the library into a new facility. She moved to the College of William and Mary in 1976 and assumed the position of law librarian and professor of law. At the Marshall-Wythe School of Law, Professor Heriot was instrumental in redrafting existing new building plans to greatly enhance the building's usefulness and potential. She also had a profound influence on collection development.

Professor Heriot served on numerous inspection teams for the American Bar Association and the Association of American Law Schools. She was also a consultant at Campbell College Law School and the University of North Dakota School of Law. She was an active member of the American Association of Law Libraries and its Southeastern Chapter, and the Association of American Law Schools and its Southeastern Conference.

Her funeral was held on Thursday, December 31, on the grounds of the Old Rembert Church in Lee County, South Carolina. A memorial service was held at the Wren Chapel on the campus of the College of William and Mary on Friday, January 15. A memorial fund has been established in her honor. Contributions should be addressed to the office of Dean William B. Spong, Jr., Marshall-Wythe School of Law, College of William and Mary, Williamsburg, Virginia 23185. One of the purposes earmarked for this fund will be the further development of the legal history collection at the library.

Professor Heriot will be remembered by many for her dedication to her profession, her unshakable will and determination, her fine sense of humor, and her immense talent. She also will be remembered for her outstanding contributions to numerous law libraries.

THE LINKS CONNECTING AALL members have generated tremendous response from the Special Interest Sections and other groups within AALL for the 1982 Convention Program. INTERLINK'82 will be crammed with events of value and interest for everyone. For starters, we have added two events for several hours daily Sunday through Wednesday: a film theater, and product demonstrations. To add to that, the program events will number up to five at one time Monday afternoon and evening and all day Tuesday and Wednesday.

The film theater will consist of a room dedicated to showing 30-60 minute long non-commercial films on many subjects; the idea is to provide some change from the usual convention fare and format. The product demonstrations are planned to allow convention goers to get a longer exposure and question-answering time with exhibitors, perhaps with the presence of librarians who are already using the product being demonstrated. These demonstrations will complement the exhibits.

THE LINK between law librarianship and substantive law is treated in programs on insurance, bankruptcy, civil procedure, copyright, and maritime law; on the connection between libraries and urban conditions; and the status of women in law librarianship.

THE LINK between law libraries and government information will be the subject of programs on government generation and distribution of information; referral services of state, federal and Canadian governments; the search for the elusive administrative decision; a documents update; and research in foreign and international law.

THE LINK between law librarians and technology connects these programs: machine manipulation of subject headings; access to on-line bibliographic files; cost-effective search techniques; automation of administration; teaching LEXIS and WESTLAW; using computers to teach; microform management; and LAWNET. The film theater and product demonstrations will also connect with this link.

THE LINK between law librarians and the consumers of legal information is the theme of panels on non-law users of the law library; public access to legal material; non-legal bibliographic needs of practitioners; the creation and use of legal research tools; and opening branch libraries for firms.

THE LINK between law librarians and the world at large is the subject of presentations on libraries and urban conditions; education for librarianship; fiscal and general management for law libraries; and underlies two proposed field trips, one to Ann Arbor to visit University Microfilms and the University of Michigan; the other, to Greenfield Village in Dearborn.
